

Our accounting department personnel also prepare the annual financial statement as per the statutory requirements along-with all relevant disclosures for on-ward submission to regulators.


We assist the accounting personnel of our clients in meeting their day to day operational needs and provide them the desired technical support and recommend improvements, where necessary.
